**Notice Concerning Organizational Changes and Changes to Responsibilities of Directors and Personnel Changes**

Miroku Jyoho Service Co., Ltd. (MJS) will make the following changes in organization, responsibilities of directors and personnel effective April 1, 2015.

1. Organizational changes (effective April 1, 2015)

(1) Description of major organizational changes

To further enhance the development system for customer-oriented products and services, MJS will reorganize and rename its Development Department to Product Development and Customer Support Department. Due to this change, Sales and Marketing Department, Product Development and Customer Support Department, Business Management Department, Internal Audit Office, President Office and Tax Accounting Research Institute will be added to this to construct a system with three departments, two offices and one research institute.

(2) Product development & Customer Support Department

MJS will place Enterprise Architecture Office, Platform Business Development Office, Cloud Service Development Office, Product Development Office, and Customer Support Center under the Product Development and Customer Support Department. Enterprise Architecture Office will enhance the development system focusing on upstream process in order to further improve customer satisfaction and product quality. Platform Business Development Office, and Cloud Service Development Office will develop and research innovative technologies, and will promote the implementation of these technologies to new products and services. In addition, for product quality control and quality improvement from customer perspective, MJS will place the Quality Management Group under the Customer Support Center engaged in call center services.
